VLAP (Volunteer Lakes Assessment Program) SAMPLES DRAWN ON 6/17/2015

Bill Schroeder, Suzanne Moore, and Ginny Campiola collected water samples for evaluation. This is the first sampling this year. The data results will be studied to help determine the chemical health and well being of our beautiful Canobie Lake. The CLPA board carefully monitors the annual results.

A FRIENDLY REMINDER...

RSA State Statute 485.22 establishes that there is a **ban on human contact with the Canobie Lake** drinking water supply for the town of Salem. This would include; no swimming, wading, water skiing, tubing, jet skis, and paddle boards.

HAVE YOU FOUND/SEEN ANY DEAD SUNFISH THIS YEAR?

Reported sightings of dead sunfish have been brought to the attention of your board. Similar sightings have been reported on Cobbett's pond and other lakes. Our NHDES VLAP Coordinator, Sara Steiner, was asked to offer a possible reason. She suggested that the temperatures were a bit abnormal this year. The dramatic change from cold to hot to cold could have created some thermal problems where the amount of dissolved oxygen on the nests and/or spawning beds was not sufficient thus causing the fish to die.
